MINUTES

Meeting called to Order by Roger Eichelberger, President at 10:10 a.m.

Agenda was handed out. No other items were added. Tom Mowrer made motion to approve agenda, seconded by Chris Milligan. Motion carried.

Minutes of November 20, 2010 meeting was read. Bob Campbell made motion to approve minutes, seconded by Tom Mowrer. All approved. Motion carried.

Financial Report was given by Norma Holcomb. In the past the board has talked about purchasing a cargo trailer, which would help to have all of our targets, tables and chairs together and storage area. Tom Mowrer made motion to purchase the tables and chairs and said he would look into some prices, seconded by Bob Campbell. Motion carried.

It was decided to leave the flyer as is but, would add "PERIOD COSTUME NOT REQUIRED".

Discussion of the Y-Heck/DNR program was discussed. Motion was made by Bob Campbell to again support this program with \$250.00 per year starting now. Motion seconded by Tom Mowrer. Motion carried.

State Pistol and Rifle flyers were approved. Targets will be ordered and there are enough medals on hand for this year.

Black Powder Cartridge flyer was approved.

Norma Holcomb discussed the present postal match and sold targets to members present. Jim said he already has received several shot targets entries. Re-read the rules and send in your targets.
